Re: Audit of Placement Report for the batch 2023-24 of Post Graduate Diploma in Management (Banking, Insurance and Financial Services)

We have audited the data related to remuneration, function & location as presented in the Placement Report prepared by you for the final placement (based on the offers received and accepted on campus) for the batch of Post Graduate Diploma in Management (Banking, Insurance and Financial Services) of Goa Institute of Management for 2023-24.

The preparation of the Placement Report is the responsibility of Goa Institute of Management (GIM). Our responsibility is to validate the information related to remuneration, function & location provided in the report with the relevant documentation and comment on the conformance of those with the Indian Placement Reporting Standards (IPRS) Revision 2.2.

In this context, we confirm the following:

1. For the purpose of the audit, we have obtained all the information and explanations, which, to the best of our knowledge and belief, were necessary. In our opinion, the data related to remuneration, function & location as presented in the Placement Report complies with the Indian Placement Reporting Standards Revision 2.2.
2. The validation of information presented in the report is based on communication received by Goa Institute of Management from recruiting companies. B2K Analytics (formerly known as Brickworks Analytics) has not independently sourced any information or documentation directly from the recruiters.

3. We have verified the information with respect to job location, function and remuneration presented in the report with communication received from recruiters by Goa Institute of Management.
 - a. The information has been categorised as best as possible under different salary heads as given in the IPRS Revision 2.2; where a break-up was not available, the salary has been considered only as 'Maximum Earning Potential'.
 - b. The data points mentioned under different salary heads are representative of aggregate salary components offered to the candidates.
 - c. Long-Term benefits like ESOPs (vested after the first year), retention bonus and any other long-term benefit to be paid after the first year have not been considered for the calculation of 'Maximum Earning Potential'.
 - d. We have considered the amount of Gratuity in the calculation of MEP even though it is payable after 5 years of service as this amount is not separately available for all the candidates.
 - e. Wherever information about added benefits for some students could not be established from the documents, the same has been confirmed by the institute. An official declaration regarding the job location details and function has been obtained from the Placement Chair (BIFS).
 - f. Wherever information was missing reasonable assumptions have been made.
4. The acceptance of offers and the number of students opting out of the placement process has been established through written communication by Goa Institute of Management.
 - a. Out of 59 students eligible for placements, 8 students opted out of placement process.
5. While auditing the data it was observed that not all the students have been offered one-time cash payments like joining bonus, retention bonus etc. Therefore, the average of one-time cash payments, represents the average of one-time cash payments actually received by the students and not the average of all the students.
