

Eligibility

For Regular Track (A candidate must hold any one of the following)

Master's degree or equivalent

- A two-year (minimum) Master's program after a Bachelor's degree with atleast 60% marks or equivalent Grade Point Average
- A two-year postgraduate diploma recognized as equivalent to a master's degree with at least 60% marks or equivalent Grade Point Average
- A professional qualification such as CA, ICWA, or CS with a bachelor's degree in commerce

Valid Test Score:

- *GMAT or GRE scores desirable for international candidates

* All scores remain valid for four years from the date of the examination and must be valid at the time of application.

For Executive Track (A candidate must hold any one of the following)

- In addition to the above, for Executive track, candidates must have a minimum of five years of full-time work experience.
